


The Town expresses gratitude to everyone who followed our ordinances and refrained from putting snow in the roads. As spring approaches, we ask residents to keep the culverts at the end of their driveways free of ice, snow and debris. This allows water to pass through unencumbered, which assists in proper draining.

Worker Safety

When you see "Road Work" "Work Ahead," and "Road Closed" signs, please be aware that people are working to make your travel better. Recently I experienced firsthand a large truck failing to slow down for the Trenton employees working on the roadside. The signs are meant to keep everyone safe. They do NOT mean that drivers should proceed quickly past the work area.

Summer DPW Activity

As in the past few years, the Department of Public Works will be cutting trees in 2019. Some areas will require road closures for safety, due to the size of the trees. Additionally, quite a lot of ditch work will be performed. The ditches will be dug out and reconstructed, to accommodate better water flow which will encourage better travel and longer-lasting roads. Please be thoughtful to the people working and SLOW DOWN, so that everyone has a safe summer.

Road work has begun in the Town already. Paradise Drive from Hwy M to South Church will be resurfaced. Also, the ditches in that area will be rebuilt. Culverts across South Church and Newark Drive will be replaced,

as well as six smaller culverts in other areas. Expect traffic delays and/or road closures in any and all culvert replacement areas.

Thank you in advance to everyone who will be affected by the summer roadwork. The ditch work will greatly improve the affected properties.

Glenway Court is also scheduled to be rebuilt this year. No additional road construction will be affordable in 2019. Although many roads need help, the Town Board would prefer not to borrow money, because of the cost of borrowing.

Culverts

Town of Trenton ordinances require every driveway to have a culvert, for numerous reasons. Culverts ensure that water drains properly and does not go onto the road. In addition, local farmers must be able to pump manure through pipes under, rather than over, the driveways.

The homeowner is responsible for ensuring that a culvert is in good working order, and free of blockages. Replacement of the driveway culvert may be necessary, in which case a permit is required. Review Town ordinances to view specifications on driveway culverts.

Snowy Cold Winter

We were there with you during the record breaking cold, the ice storms and the snow storms. I am happy to report we had very few vehicles in ditches and it was rare to hear of any problems with cars on the roads during the snowplowing. We thank you for that! Looking forward to a long warm summer season!

New Squad Car

Like all things mechanical our squad car was replaced in March. It won't look any different than the last one because we ordered the same make and model. For safety the vehicle will have a brighter light bar replacing the one that was 13 years old. Our venders are great to law enforcement and we save big money on replacement squads. We also sell the old squad which helps to off-set all costs. This vehicle will carry a fire suppression system and a new defibrillator replacing our original one purchased in 1998. We were among the first departments to carry such a device and we have saved lives!

Officer Safety

More officers die each year from traffic related

matters on duty than by all other means. When you see that a squad car is at the side of the road with traffic or other matters please slow down and move over. In our area this is possible because of the type of roadways and traffic volume.

School Bus Safety

Like with the traffic stops remember that school



buses have special right-ofway status on the roadways. You will see the lights flash yellow indicating that a stop is coming and then the flashing red. You must stay back you may not pass and you must stop! I always tell people "WHEN IN DOUBT WAIT IT OUT!"

Burning

Remember that you may burn small bonfires and leaves but that you may not burn anything that is made from rubber or plastics etc. This includes but is not limited to carpet, rubber, plastic containers, and on and on.

Property Tax Instruction sheet that accompanies your Property Tax bill has really useful information in it? Are you also aware that the majori-



ty of Town residents confess to **NOT READING IT?** You know who you are! We do hope that rather than simply tossing all that paperwork, you turned over the letter to see the 2019 COLOR Trash and Recycling Collection Calendar.

Here are a few reminders, some of which are new procedures:

- Payment receipts will be printed for in-person property tax collection during listed hours
- Receipts will be printed and mailed only if a selfaddressed, stamped envelope is provided
- After January 31, tax payments <u>must</u> be paid at

the County Treasurer's office, not at the Town of Trenton

- The deadline for dog license registration/ renewal is April I
- Online access to property records is available via the Property Taxes page on our website, www.townoftrenton.info.

Curbside Voting

If physical limitations make it difficult for you to enter

the polling location, Absentee Voting by mail is a great op-

tion. You can also vote curbside at the polling place. Two Election Inspectors will bring your ballot to you and conduct voting at your vehicle or at the polling place available. If you vote abscurbside, you are not required to sign the poll list; the ple Election Inspectors will write

"exempt by order of inspectors" in the signature space on the poll list.

You may also register to vote curbside with a current and valid Proof of Residence document.

(keyboards, mice, hard drives, modems), fax machines, DVD players, VCRs, DVRs, cell phones. NO household appliances or hazardous waste will be collected. Be prepared to prove Town of Trenton residency.

Collection Facts

Advanced Disposal provides the Town with curbside trash and recycling collection. Certain white or gray trucks used for collection have "split" receptacles and can accommodate both trash and recycling. Green trucks are exclusively used for either trash or recycling.

Recycling Plastic

Recycling plastic is important. Used plastics are versatile and adaptable. The large market for recycled plastic bottles and containers helps keep that valuable material out of landfills and reduces energy use and emis-

sions.

Knowing what types of plastic can be recycled can be confusing. Plastic containers for beverag-

es, foods, and household cleaners, bottles for shampoo, body wash, and other toiletries, plus caps and lids, are all recyclable.

For lotion bottles and other toiletry items, empty the contents, rinse, and discard the pump (if any). For no-pump containers, rescrew the cap to keep it all together, and recycle. Once collected, mixed plastics are sorted, baled, and sent to a reclaiming facility, where they are cleaned, washed, and ground into flakes, then dried, melted, filtered, and formed into pellets. These are sent to a manufacturer to be heated and remolded into a new product.

Depending on the kind of plastic, recycling might give a product new life as fiber for clothing, carpeting, or car parts. Or it could become a cutting board, a durable outdoor deck, plastic lumber, playground equipment, or

even a recycling bin.

Plastic bags and flexible wraps, also knows as "film." are part of a category which includes retail bags, dry cleaning bags, bread bags, shipping pillows, sealable or "zippered" plastic food bags, flexible plastic wraps on paper towels, cases of soda, and more. Recycling these plastics reduces litter, lessens the amount of waste going to landfills, and gives a valuable resource a second life.

Plastic bags and film cannot be collected at the curb. Return them to labeled receptacles, available at grocery and retail outlets. Do not include food or cling wrap, prepared food bags, biodegradable bags, or film that has been painted or has excessive glue.

Collected plastic bags and film are baled and sent to recycling centers, where they are cleaned, processed, and turned into flakes and pellets. The pellets are used to make new plastic shopping bags, durable outdoor fences, decks, shop-

ping carts, and home building products.

The keeping

You may be surprised to learn that Subsection E of Town Ordinance §158-7 (Restrictions on keeping of animals) discusses the accumulation of animal waste products (defecation). It is unlawful in the Town of Trenton for any person to

large, among other things.

allow his or her animal to poop on a neighbor's property without removing it within a

reasonable time, which will vary upon circumstance. The best option is to carry bags when walking your dog, so you can clean up their mess immediately. Horse manure must be cleaned up as well, within a reasonable time.

You may believe that because the Town of Trenton is largely ruralresidential, that cleaning up after your dog is not necessary. However, imagine walking along the road, stepping off the road to avoid an oncoming car right into a pile of dog poop that someone neglected to remove. Also, assuming that your neighbor's empty field is really a toilet for your animal is not very respectful. If your pet leaves a mess on property **not** your own, pick it up!

Be a responsible pet owner and clean up after your animal.
