#### Town Administrator

In response to the growing needs of residents, the town recently appointed Cindy Komro to the position of Town Administrator. Cindy, who has worked for the town for over 17 years, began her new role in January.

The Town Administrator is responsible for many duties, most notably, those of the Zoning Department. As the Zoning Administrator, Cindy will respond to resident questions; issue zoning permits; manage applications for Certified Survey

Maps, Conditional Use Permits and Comprehensive Plan Amendments; and advise the Planning Commission and Town Board on zoning issues.

In addition, the Town Administrator is responsible for managing the town annual budget, serving as personnel officer for town employees, and representing the town in legislative and intergovernmental affairs, among other things.

## Town Clerk

The town is excited to welcome Heather Krueger, who was appointed to the Town Clerk position in February. Heather comes well qualified with six years' experience as Clerk of the Town of Port Washington. She is

also a Certified Municipal Clerk, the result of many hours of training and on-the-job experience. Heather had the opportunity to meet many Tren-

I'm so excited to serve this town, its heritage and residents in the coming term.



#### Town Hall Office Hours

With a full-time Administrator, the town hall office is now open Monday through Friday from 9:00 a.m. to 4:00 p.m. These hours are staffed by the Administrator, Clerk

and/or Treasurer. Occasionally, off-site meetings and other conflicts will affect these hours. Residents are encouraged to call ahead to



make sure the official they wish to meet with is in the office when they intend to visit. Building Inspector Walt Grotelueschen will be adjusting his hours at the town hall. Beginning June, he will be available on **WEDNESDAYS** from

3:00-5:00 p.m. (his current hours are on Thursdays at the same time).

## **Curbside Collection Vendor**

Harter's Lakeside Disposal began providing curbside collection service to town residents on January I. The town is grateful for the work by the Refuse and Recycling Contract Committee consisting of former Town Supervisor Jeff Esselmann and town residents. This committee spent countless hours drafting and finalizing the terms in the Request for Proposals, which led to the new contract.

In January, each residence was provided two 95-gallon carts—one for trash and one for recycling. Trash is collected each week and recycling is collected every other week. The cost of

this service is added to the property tax bill. Additional curbside services are available directly from Harter's at an additional charge.

Some residents have expressed interest in smaller (65-gallon) carts. To request an exchange for the smaller carts, please call Harter's directly at 833.754.2158.

A regular concern expressed by residents relates to the difficulty keeping trash and recycling from blowing around on windy days. If you

are in an area with high wind, such as Highway 33, Harter's approves use of the SafeWaste Push Clip. This rubber clip, available on Amazon.com for about \$15, is attached to your cart to keep the lid closed until it is tipped into

the truck. A sample of this clip is available at the town hall. Another option on windy days is to place the cart "backward." The driver will maneuver the cart to the proper direction for dumping.

Harter's requests that this option ONLY be used on windy days.

The contract with Harter's provides for an annual electronics recycling event, which will be held on Saturday, September 9 from 8:00 a.m.—noon at the town hall.

In response to continued requests from residents for an option to dispose of yard waste, the refuse and recy-

cling contract provides for a dedicated seasonal dumpster at the town hall. Leaves and grass clippings may now be disposed of on regular recycling days

(second Saturday and fourth Thursday). Yard waste and the bags used for disposal MUST be entirely compostable. Large compostable bags specifically for yard waste are available for purchase at such retail establishments as Fleet Farm, Menards, Home Depot, and Costco.

#### Resident Portal on Website

A new feature on the town website's bulletin board and Garbage/Recycling pages is a "resident portal" for easy reporting of issues such as:

- Curbside collection issues, including missed collection and repair or replacement of trash and recycling carts
- Public works issues, including snow removal, roadway debris, and sign damage

The town is also considering a future option to allow residents to get email and text notifications regarding things like trash and recycling delays, burn bans and other notices.

## Town Continues Growing

The number of residents in the Town of Trenton continues to hover just under 5,000. However, building in the town has been robust for

the past few years. In 2022, 17 permits were issued for new homes. Trenton is clearly seen as a great place to live!

## **Backyard Chickens**

Due to countless requests over the past several years, the Town Board recently ap-



proved
amending
town ordinances to
allow raising small
flocks of
chickens in
R-I and R-2

Zoning Designations. (Chickens are already allowed in other zoning designations.) Depending on your zoning and lot size, flocks of five to eight hens (no roosters) are allowed. A permit is required and must be renewed annually.

Elections in an "odd" year in Wisconsin are only held in the spring, which means we are done with elections for 2023. "Even" years have up to four elections, depending on whether a February primary is needed, so get ready for 2024!

Remember to register early when you have a change of name or address. Online registration is quick and easy via <u>MyVote.wi.gov</u>.

As a reminder, Wisconsin State Statute §12.04 requires

election campaign signs to be removed the day after an election. Often the candidate will collect their signs to be reused or recycled. Otherwise, the resident is responsible for their removal.

## TREASURER INFO

#### **Lottery Credit**

Earlier this year, misstated or misinterpreted information regarding the state lottery credit was circulated. This caused alarm for residents and frustration for municipal treasurers.

The state Lottery and Gaming credit provides direct property tax relief to qualifying taxpayers on their property tax bills. To qualify, Wisconsin residents must own a dwelling that is used as their primary residence. The credit would be applied on your

2023 tax bill if you used your home as your primary residence on January I, 2023.

Residents must apply for this credit with the Washington County Treasurer. Once you qualify, you need not reapply each year.

## **PUBLIC WORKS**

### 2023 Road Work

The Newark Dr Rehabilitation Project, rebuilding the road from Trenton Rd to Indian Lore, is scheduled to begin in May and be completed in October. Michels Road & Stone, Inc. was awarded the bid at a cost of \$978,023.25. Sixty-nine per-

cent of the total cost is expected to be recovered by a road grant.



Chipsealing in the town will commence in July or August. After the work is completed, the roads will be swept and cleared within 7-10 days. The following roads are scheduled for chipsealing:

 Scenic Dr (Hwy 33 to end)

- Wausaukee Rd (#5828 to Pleasant Hill Dr)
- ◆ School Rd (Lincoln Dr to Paradise Dr)
- Evergreen Dr (Hwy I to end)

### Winter Damage

Due to the snowy winter and lack of frost, heavy damage was sustained on many of the road shoulders in the

town. The Department of Public Works has completed shoulder restoration work.

Public Works has also repaired the lawns that sustained damage by snowplows during the winter season.



- Vivian Stockhausen Park, on the northeast corner of Cecelia Dr and Berna-
- dine Cir, has a swing and picnic bench
- Washington County Goeden Park, located on the Milwaukee River on the southwest corner of Hwy 33 and County Hwy M, has access to the river for canoes and kayaks
- Washington County Sandy Knoll Park is located at 2064 Wallace Lake Rd. This park has reservable shelters, a beach, hiking trails and a dog park, among other amenities. Sandy Knoll is one of the County parks requiring a park pass.
