Bids must certify that the State of Wisconsin and the Town's specifications and standards will be met. Bids not meeting the State DOT and Town's specifications and standards will not be considered.

- Hot Mix Asphalt (including wedging). SEE NOTICE RE: STANDARDS AND SPECIFICATIONS ABOVE. MATERIALS MIX STANDARDS ARE INCLUDED IN THESE SPECIFICATIONS. Bidder to quote price per ton laid down, also price per ton at plant. Bidders should submit TWO bids: (1) quoting virgin material; and (2) quoting recycled material.
- 2) Pulverize, grade and roll old road surface. SEE NOTICE RE: STANDARDS AND SPECIFICATIONS ABOVE. Bidder to quote price per square yard.
- 3) Gravel. Rolled, compacted, graded and watered. Bidder to quote price per ton.
- 4) Shoulder gravel (TB) or alternative. Bidder to quote price per ton. Delivered to Town or pickup by Town.
- 5) Crackfilling and cracksealing (MAY BE BID SEPARATELY). SEE NOTICE RE: STANDARDS AND SPECIFICATIONS ABOVE. Bidder to quote price PER ROAD TO BE CRACKFILLED. Material to be used should be the vendor's highest quality crack sealant. Cracks to be routed to approximately 1:1 ratio. Crack sealant to be applied must meet or exceed Specification ASTM D 3405.
- 6) Chipsealing (MAY BE BID SEPARATELY). SEE NOTICE RE: STANDARDS AND SEPCIFICATIONS ABOVE. Bidder to quote price PER ROAD TO BE CHIPSEALED. Note that all work must be completed within 7-10 days, including sweeping/cleaning of road surfaces. Bids to include black slag or limestone chips. - 7) Backhoe Price per hour with or without operator.
