

Minutes from the Town of Trenton Town Board Meeting

Date and Time: January 5, 2021, 7:30 PM

Location: Town of Trenton Town Hall, 1071 Highway 33 East, West Bend, WI 53095

Present: Chairman Joseph Gonnering, Supervisor Ed Doerr, Supervisor Jeff Esselmann, Clerk Cindy Komro, Zoning Administrator Barbara Davies, Attorney Tim Schoonenberg.

Chairman Joseph Gonnering asked those in attendance to stand and recite the Pledge of Allegiance. Gonnering called the Meeting to order at 7:30 P.M.

1. Approve Minutes of Town Board Meeting of December 15, 2020:

Ed Doerr moved to approve the minutes of the Town Board meeting of December 15, 2020; Jeff Esselmann seconded. Motion passed 3-0.

2. Affidavit of Posting:

Chairman Gonnering read the affidavit of posting, that notice was properly posted prior to the meeting on the Town Bulletin Boards and sent to Washington County Daily News and WIBD Radio.

3. Comments and Questions from the Audience:

4. Review and Accept Agenda:

Jeff Esselmann moved to approve the agenda as presented; Ed Doerr seconded. Motion passed 3-0.

6. December Bank Statement Reconciliations:

Ed Doerr moved to approve the December Bank Statement reconciliations; Jeff Esselmann seconded. Motion passed 3-0.

7. Plan Commission Dinner:

Chairman Joseph Gonnering Ed Doerr moved to increase the Plan Commission Dinner gift cards by \$40; Jeff Esselmann seconded. Motion passed 3-0.

8. Driveway Permit Exception, 791 Hwy 33:

Zoning Administrator Barbara Davies explained that the property at 791 Hwy 33 touches both Riverview Drive and Hwy 33. The property has one driveway stretching the length from Riverview Drive to Hwy 33. The property owner is interested in finishing the driveway to blacktop, and explained the unique circumstances at this residence. Acceptable culverts exist for each driveway. Jeff Esselmann moved to approve the Driveway Permit allowing the driveway improvements (including exception for culvert size 12" and allowing, in effect, two driveways); Ed Doerr seconded. Motion passed 3-0.

9. Grass Cutting Bid Opening Date:

Jeff Esselmann moved to set grass cutting bid opening date to March 16, 2021; Ed Doerr seconded. Motion passed 3-0.

10. Advanced Disposal/Waste Management Contract:

Attorney Tim Schoonenberg presented the Proposal from MCE regarding 2198 Wallace Lake Road. Discussion followed.

Chairman Joe Gonnering reported on DPW activity. Gonnering reported on an upcoming foreclosure of the Paradise Hills subdivision.


16. Payment of Bills and Property Tax Refunds:
