

Minutes from the Town of Trenton Town Board Meeting

Date and Time: February 16, 2021, 7:30 PM

Location: Town of Trenton Town Hall, 1071 Highway 33 East, West Bend, WI 53095

Present: Chairman Joseph Gonnering, Supervisor Ed Doerr, Supervisor Jeff Esselmann, Zoning Administrator Barbara Davies. Excused: Clerk Cindy Komro (election).

Chairman Joseph Gonnering asked those in attendance to stand and recite the Pledge of Allegiance. Gonnering called the Meeting to order at 7:30 P.M.

1. Approve Minutes of Town Board Meeting of February 2, 2021:

Jeff Esselmann moved to approve the minutes of the Town Board meeting of February 2, 2021; Ed Doerr seconded. Motion passed 3-0.

2. Affidavit of Posting:

Chairman Gonnering read the affidavit of posting, that notice was properly posted prior to the meeting on the Town Bulletin Boards and sent to Washington County Daily News and WIBD Radio.

3. Comments and Questions from the Audience:

4. Review and Accept Agenda:

Ed Doerr moved to approve the agenda as presented; Jeff Esselmann seconded. Motion passed 3-0.

5. Police Department Report:

6. Mid Moraine Municipal Court Agreement 14:

The Town of Jackson voted to reject the agreement at its meeting. 100% unanimous vote by all municipalities is required for approval. Ed Doerr moved to approve the Mid Moraine Municipal Court Agreement 14; Jeff Esselmann seconded. Motion passed 3-0.

7. Athletic Field Use 2021:

Jeff Esselmann moved to permit the YMCA to use the Athletic Fields beginning in June, 2021. Attorney Schoonenberg recommended asking the YMCA for a waiver if COVID is a concern. Jeff Esselmann added that the restrooms be left open but ask the YMCA to take responsibility for cleaning the restrooms. Esselmann requested a donation pledge of \$400 per sport for the year. Ed Doerr seconded. Motion passed 3-0.

8. Ordinance 2021.02.01, Preliminary Plat Recommendation to Town Board – Green Acres, DAM Properties LLC:

Ed Doerr moved to approve Ordinance 2021.02.01; Jeff Esselmann seconded. Motion passed 3-0.

9. Ordinance 2021.02.02, Amendments to Town Ordinance §§ 380-33, 380-34, 380-128

Jeff Esselmann moved to approve 2021.02.02; Ed Doerr seconded. Motion passed 3-0.

10. Department Reports:

Zoning Administrator Barbara Davies reported that Clerk Cindy Komro is requesting newsletter articles for the Spring Town Crier.

Supervisor Jeff Esselmann had nothing further to report.

Supervisor Ed Doerr reported on Newark Drive. He had an amicable meeting with the property owner of a fence encroaching on the road right of way on a section of Newark Drive maintained by the Town of Trenton. The property owner asked for a month or two to contact fence companies regarding his

options for the fence. Attorney Schoonenberg will draft a letter to the property owner recapping the discussion with Supervisor Doerr.

Attorney Schoonenberg reported that he had spoken with the structural engineer who will be inspecting the property at 2198 Wallace Lake Road. The report should be issued in a few weeks.

Chairman Joe Gonnering reported an old fashioned winter with lots of snow.


11. Payment of Bills and Property Tax Refunds:
