

Minutes from the Town of Trenton Town Board Meeting

Date and Time: March 2, 2021, 7:30 PM

1. Approve Minutes of Town Board Meeting of February 16, 2021:  
Jeff Esselmann moved to approve the minutes of the Town Board meeting of February 16, 2021; Ed Doerr seconded. Motion passed 3-0.
2. Affidavit of Posting:

Chairman Joe Gonnering reported on activity in the Department of Public Works.


16. Payment of Bills:
