Specifications: the Contractor shall provide and pay for all materials, labor, tools, equipment, water, light, heat, power, transportation, superintendence, temporary construction, of every nature, charges, levies, fees or other expenses incurred, and all other services and facilities of every nature whatsoever, as necessary to properly demolish and remove all structures included in these specifications, fill and grade the entire parcel in the specified time and in accordance with all applicable ordinances and codes of local, state, and federal governments in the performance of the contract.

Bids must be received no later than Tuesday, March 21, 2023 at 7:30 p.m. Bids will be publicly opened at that time in the town meeting room of the Municipal Building located at 1071 State Hwy 33E, Trenton, Wisconsin. Award will be made to the lowest, best, most responsible bidder, or the bid most advantageous to the Town. The Town Board reserves the right to reject any and all bids, to waive any formality of bidding or to accept such bid or bids as will in its opinion be most advantageous to the Town of Trenton.
