
Chairman Gonnering asked those in attendance to stand and recite the Pledge of Allegiance. Gonnering called the Meeting to order at 7:30 P.M.

1. Approve Minutes of Town Board Meeting of December 20, 2022:  
Ed Doerr moved to approve the minutes of the Town Board meeting of December 20, 2022; Joe Gonnering seconded. Motion carried 3-0.
2. Affidavit of Posting:
