

Minutes from the Town of Trenton Town Board Meeting

Date and Time: July 5, 2022, 7:30 PM

1. Approve Minutes of Town Board Meeting of June 21, 2022:
Jeff Esselmann moved to approve the minutes of the Town Board meeting of June 21, 2022; Joe Gonnering seconded. Motion carried 2-0.
2. Affidavit of Posting:
Chairman Gonnering read the affidavit of posting, that notice was properly posted prior to the meeting on the Town Bulletin Board and the Town official website and was also sent to the Washington County Daily News and WIBD Radio.

Joe Gonnering opened discussion regarding the trash and recycling contract which will expire on December 31, 2022. Jeff Esselmann offered to create a committee to consider. Discussion followed regarding possible committee members. Jeff Esselmann moved to consider sealed bids for a new trash and recycling contract at the October 18, 2022 Town Board meeting; Ed Doerr seconded. Motion carried 3-0.

Joe Gonnering reported on Wausaukee Road and Paradise Drive work.
11. Department Reports:
Zoning Administrator Barb Davies reported on activity in the Building and Zoning Departments.

Clerk Cindy Komro reported on upcoming Clerk and Treasurer training the week of July 11, on the sample Athletic Field Usage Forms, on the ARPA fund balance and on election notices mailed recently.

Supervisor Jeff Esselmann reported on traffic control on Newark and N Church, on a road sign needing repair, on culvert inventory, on the athletics field lights and on access to the Hunters Grove development.

Supervisor Ed Doerr reported on weed growth in the town.

Chairman Joe Gonnering reported on activity in the Department of Public Works.


12. Payment of Bills:
