The land use category in the Town of Trenton Comprehensive Plan:2050 for these parcels is inconsistent with the parcel sizes as divided. Applicants have therefore requested an amendment to the land use plan map adopted by the Town Board as part of the Town of Trenton Comprehensive Plan:2050 from Medium Density Residential and Isolated Natural Resource Area to Suburban Density Residential. The portion of the parcel that is in Isolated Natural Resource Area is to remain in that land use designation.


