Application of American Transmission Company LLC, as an Electric Public Utility, for a Certificate of Public Convenience and Necessity to Construct and Operate the Ozaukee Co. Distribution Interconnection Project, Consisting of Two New Double-Circuit 345 kV Transmission Lines to Interconnect the Proposed Decker Substation Located in Port Washington, Ozaukee Co., Two New 138 kV Transmission Lines from the Proposed Adell Substation Located in Sherman, Sheboygan Co. to the Holland Substation Located in Holland, Sheboygan Co., Rebuilding and Upgrading Existing Transmission Lines to Connect a New Proposed Mullet River Junction Substation Located in Lima, Sheboygan Co. with a new proposed Cedar Creek Junction Substation Located in Jackson, Washington Co., Building a New 345 kV Transmission Line from the Forest Junction Substation Located in Brillion, Calumet Co. to a New Proposed Sheboygan River Jct. Enclosed is an electronic copy of an initial application filed with the Public Service Commission of Wisconsin (Commission) by American Transmission Company LLC (applicant). The application seeks authority to construct and place into operation the Ozaukee County Distribution Interconnection Project. The proposed project consists of new transmission lines, rebuilding and upgrading existing lines, and the construction of up to five new electrical substations.

New substations are proposed to be constructed in the Town of Osceola, Fond du Lac County, the Town of Port Washington, Ozaukee County, the Towns of Lima and Sherman, Sheboygan County, and the Town of Jackson, Washington County.

Two route alternatives are proposed for new transmission lines. Primary route transmission lines, if selected, would be located in Town of Brillion, Town of Brothertown, Town of Chilton, and Town of Woodville (Calumet County); Town of Calumet, Town of Empire, Town of Forest, Town of Marshfield, and Town of Osceola (Fond du Lac County); Town of Port Washington, Town of Saukville (Ozaukee County); Town of Greenbush, Town of Lima, Town of Lyndon, Town of Mitchell, Town of Rhine, Town of Russell, Town of Scott, and Town of Sheboygan Falls (Sheboygan County); and Town of Farmington, Town of Jackson, and Town of Trenton (Washington County).

Alternate route transmission lines, if selected, would be located in City of Chilton, Town of Brillion, Town of Charlestown, Town of New Holstein, Town of Rantoul (Calumet County); Town

Existing transmission line modifications are proposed in the Town of Ashford, Town of Eden, Town of Forest, Town of Osceola (Fond du Lac County); Town of Cedarburg, Town of Saukville, Town of Fredonia, Village of Fredonia (Ozaukee County); Town of Cato, Town of Franklin, Town of Liberty, Town of Meeme (Manitowoc County); Town of Herman, Town of Holland, Town of Mitchell, Town of Lima, Town of Lyndon, Town of Sheboygan Falls (Sheboygan County); and Town of Addison, Town of Hartford, Town of Jackson, Town of Polk, Town of Trenton, Town of Wayne, Village of Germantown (Washington County).

Pursuant to Wis. Stat. § 196.491(3)(a) and Wis. Admin. Code § PSC 111.51(4), the Commission has directed the applicant to send an electronic copy of the application to the clerk of each municipality, town, and county in which the proposed facilities will be located and to the main public library and local libraries in the proposed project area. Please place this electronic copy, along with a copy of this letter, in an area where it will be available for public review until March 30, 2026.

When the application is found by the Commission to be complete, a copy will be provided to you. Additional correspondence will also be provided to you, other interested parties, and all landowners potentially affected by the proposed project. These correspondences will list your office as a location where the public may review the project application.

All documents relating to the project may be viewed through the Electronic Records Filing system at the Commission's website, http://psc.wi.gov. The docket number 137-CE-221 listed above is required to access the documents.
