**NOTICE OF PUBLIC HEARING – PETITION FOR AMENDMENT TO TOWN ZONING MAP AND  
ACCOMPANYING CONDITIONAL USE PERMIT APPLICATION**

NOTICE IS HEREBY GIVEN that a Public Hearing will be held before the Town of Trenton Board and Plan Commission at the Town of Trenton Town Hall, 1071 STH 33 East, West Bend, WI 53095 at 6:15 p.m. on Monday, January 12, 2026. The Public Hearing will be held to accept public comments on an application submitted by Rob n Cin Farms, LLC. In accordance with Town Zoning Ordinances, Chapter 380, Article XII Changes and Amendments, Rob-n-Cin Farms has petitioned the Town to amend the Town of Trenton Zoning Map from EA Exclusive Agricultural District to AE Agricultural Enterprise District for Tax Key Numbers identified as T11\_065200C and T11\_064200D totaling approximately 141.34 acres. The amendment is requested to allow Applicant to apply for a Conditional Use Permit to expand its existing livestock facility under Town Ordinance Section 380-14C, Subsection (13) Livestock facilities of 1,000 or more animal units.

Rob-n-Cin Farms has included in its petition an application for a Conditional Use Permit (pending the outcome of the Zoning Map Amendment) to allow an expanded livestock facility of no more than 2,500 animal units.

During the Public Hearing, Town of Trenton residents are invited to speak on the proposed amendment and Conditional Use Permit.

Written comments by any member of the public may be submitted to the Town Administrator and shall become part of the record. Written comments must be received by the Town Administrator no later than 3:00 p.m. on Monday, January 12, 2026 by email to [townadmin@townoftrenton.wi.gov](mailto:townadmin@townoftrenton.wi.gov), or by postal mail or personal delivery to 1071 Hwy 33, West Bend, WI 53095.

The Public Hearing will be closed when all interested town residents in attendance have had the opportunity to offer comments. Upon the closure of any and all Public Hearings scheduled for Monday, January 12, a meeting of the Trenton Plan Commission shall be called to order, and the amendment shall be addressed per the agenda.
