

**NOTICE OF TOWN BOARD OF SUPERVISORS PUBLIC HEARING  
PETITION TO AMEND TOWN COMPREHENSIVE PLAN LAND USE MAP:2050  
AND TOWN ZONING MAP  
ORDINANCE Z2026.\_\_\_\_.\_\_\_\_**

NOTICE IS HEREBY GIVEN that a public hearing will be held before the Town of Trenton Board of Supervisors at the Town of Trenton Town Hall, 1071 STH 33 East, West Bend, WI 53095 at 6:55 p.m. on Monday, July 20, 2026. The Public Hearing will be held to accept public comments on a petition to amend the Town of Trenton Comprehensive Plan Land Use Map: 2050 and the Town of Trenton zoning map.

Applicants Daniel and Nancy Legate have petitioned the town to amend the Comprehensive Plan Land Use Map: 2050 and the zoning map. One acre of parcel T11\_040700E (13.58 acres) owned by Timothy and Emily Legate was transferred by quitclaim deed to parcel T11\_040700C (1.2 acres) owned by Daniel and Nancy Legate. The resulting parcel T11\_040700G (2.2 acres) is in the R-2 Single-Family Residential District and the resulting parcel T11\_040700H (12.58 acres) is in the CES-5 Country Estate Zoning District and parcel T11\_040700C

An amendment to the Town of Trenton Comprehensive Plan Land Use Map: 2050 from Country Estates to Low-Density Residential is required for the acre transferred.

An amendment to the Town of Trenton zoning map from CES-5 Country Estates District to R-2 Single-Family Residential Zoning District is required for the acre transferred.

**The legal description for the portion transferred is as follows:**

That part of the Southwest Quarter of the NORTHEAST Quarter (SW 1/4 NE 1/4) of Section Fourteen (14), Town Eleven (11) North, Range Twenty (20) East, Town of Trenton, Washington County, Wisconsin, described as follows:

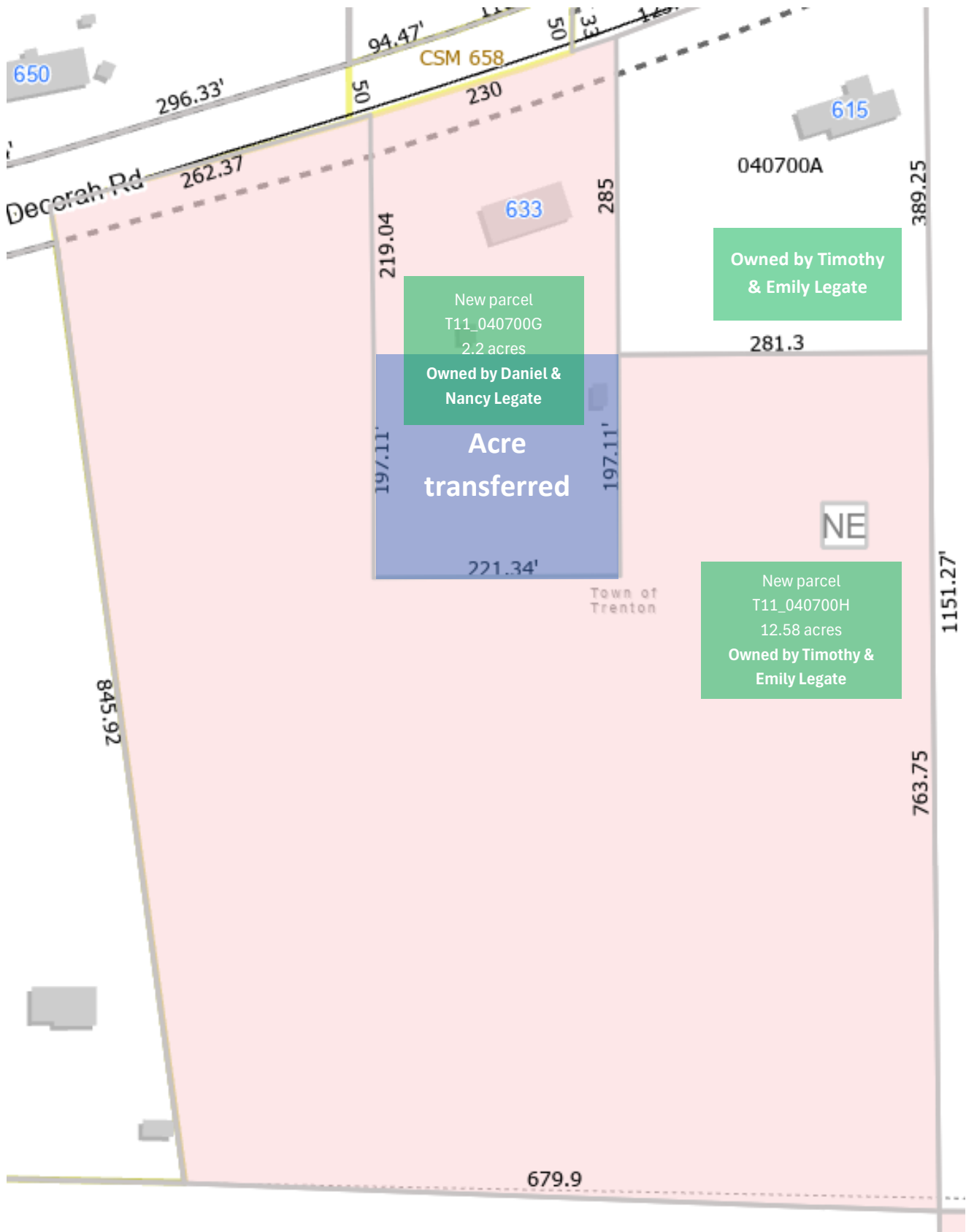
Commencing at the East Quarter corner of said Section 14; thence North 89° 46' 26" West along the South line of said Northeast 1/4, 1325.74 feet to the Southeast corner of said Southwest 1/4 of the Northeast 1/4 of Section 14; thence North 01° 32' 53" West, along the East line of said Southwest 1/4 of the Northeast 1/4, 756.58 feet; thence South 88° 41' 53" West, 282.74 feet to the point of beginning of lands herein described; thence South 01° 26' 21" East, 197.11 feet; thence South 88° 41' 53" West, 221.34 feet; thence North 01° 14' 45" West, 197.11 feet; thence North 88° 41' 53" East, 220.67 feet to the point of beginning.

The public hearing will be closed when all interested parties in attendance have had an opportunity to offer comments. Upon the close of all public hearings scheduled for Monday, July 20, a meeting of the Town of Board of Supervisors shall be called to order and the application shall be addressed per the agenda.
