NOTICE IS HEREBY GIVEN that a Public Hearing will be held before the Town of Trenton Plan Commission at the Town of Trenton Town Hall, 1071 STH 33 East, West Bend, WI 53095 at 6:55 p.m. on Monday, October 12, 2026. The Public Hearing will be held to accept public comments on an application submitted by Cream Street LLC (Brian Feucht, member) to amend the Town of Trenton Comprehensive Plan:2050 land use map and Town of Trenton zoning map for parcel T11\_024100A at 1214 Hwy 33, West Bend, Wisconsin (38.41 acres).

The following amendments have been requested to accommodate the change from school use to business office use:

- Comprehensive Plan Map amendment from Government, Institutional and Utilities to Commercial land use
- Zoning Map amendment from I-1 Institutional to B-1 Local Business District

The public may review copies of the application and Comprehensive Plan:2050 at the Town Hall during regular office hours or may request a copy of the application by contacting Cindy Komro, Town Administrator ([townadmin@townoftrenton.wi.gov](mailto:townadmin@townoftrenton.wi.gov) or 262.675.6009 x106).

Town of Trenton residents may present public comments on the proposed amendments during the public hearing. Written comments may be submitted by any member of the public and shall become part of the record, provided they are received by the Town Administrator ([townadmin@townoftrenton.wi.gov](mailto:townadmin@townoftrenton.wi.gov) or 1071 Highway 33, West Bend, WI 53095 no later than 10:00 a.m. on Monday, October 12, 2026. The Public Hearing will be closed when all Town residents in attendance have had an opportunity to offer comments. Upon the close of all Public Hearings scheduled for Monday, October 12, a meeting of the Trenton Plan Commission shall be called to order and the application shall be addressed per the agenda.
